I further agree to hold myself solely responsible for understanding and following Canadian and International Copyright laws and for honoring all copyright requirements accompanying any audio media I have transferred by Henry Kreindler and Associates. By enlisting Henry Kreindler and Associates' services I acknowledge the media given to Henry Kreindler and Associates by me are the originals and that prior to the transfer, no previous copies of this media, in any format, were in existence.
